Facility Charge Increase Effective January 1

The Heartland Power Cooperative Board of Directors approved an increase in facility charges for rural residential, farm, and small commercial rate classes. The decision was based on a thorough cost-of-service study conducted by the cooperative's rate consultant.

The new facility charges took effect on January 1, 2026. For rural residential, farm, and small commercial members, the facility charge increased by \$3. Specifically, single-phase charges increased from \$47 to \$50, while three-phase charges went from \$67 to \$70.
